

PARTICIPATORY POLICY DESIGN

In order to learn to optimally manage serious fragilities and produce real change, it is necessary to have the skills to **innovate**, **improve and implement effective social practices**. We are committed to providing partner institutions and bodies with all the knowledge necessary to deal with any difficulties. In fact, many of our projects involve **training relevant personnel** from a policy design perspective aimed at promoting participatory welfare capable of **guaranteeing effective results** in the management of complex phenomena and to **generate a positive social impact**.



SOCIETING - MIGRANT INTEGRATION

It is important to include the **integration of migrants and refugees in regional and social cohesion policies**. We aim to facilitate, guide, and enhance the work of the regions through innovative tools: we are committed to systematising a range of reception and integration services and **efficiently meeting the needs of migrants as well as those of the host society**.



DECENT WORK - CONTRASTING THE EXPLOITATION OF LABOUR AND ILLEGAL RECRUITMENT

Illegal recruitment is a harsh reality in Italy; it is a form of **worker exploitation via illicit intermediation, recruitment and labour organisation**. It is a widespread phenomenon primarily affecting irregularly employed non-EU nationals illegally employed in the agricultural sector; however, Italians and minors can also be victims. We strive to combat and overcome all forms of severe labour exploitation, severe marginalisation, and vulnerability of migrant workers in the most critical areas.



EQUAL OPPORTUNITIES FOR YOUNG PEOPLE

There are around three million young people between the ages of 15 and 29 who neither study nor work; they are young men and women often living in disadvantaged conditions without access to income and with no vision of the future. It is important that these young people do not feel alone. **We work to guarantee equal opportunity to young men and women,** in particular adolescents at risk of social exclusion and dropping out of school. We do this through literacy programs, school-work apprenticeship programs, and promoting youth leadership and associationism by working side by side with institutions, schools and the third sector.

EURegionsWeek -European Week of Regions and Cities 2023

It is an annual event in Brussels organised by the the European Commission's European Committee of the Regions. Since its first edition in 2003, it has grown to become a one-of-a-kind communication and networking platform, an unmissable moment of meetings between Regions and cities from all over Europe in the presence of political representatives, officials, experts and academics. This year's edition included our Su.Pr.Eme. Italia project as a good practice in the topic of social innovation.

We organised the Participatory – Political Lab entitled "Five Italian Southern Regions promoting integration strategies and migrant worker's rights: Supreme", in which we talked about Su.Pr.Eme. as a shared strategies model based on a place-based approach, co-organised and implemented

by a multi-level and inter-regional governance system involving more than 120 local stakeholders and developed evidence-based solutions integrating housing, public services, access to work, and responses to the needs and potential delays of the territories. Our participation in EuRegionsWeek was an important recognition of our work and allowed us to compare ourselves to other organisations active on the same issues at a European level. The event as a whole was a success: more than 10,000 participants - including more than 1,000 speakers from across Europe and beyond - with an extensive program of conferences, exhibitions and networking events on regional and local development. Its media impact was notable: around 300 journalists from European print, radio, TV and online media reported on it.

Italy & the Netherlands Exchange on Legal Migration & Integration

The Netherlands Enterprise Agency (RVO), part of the Netherlands Ministry of Economic Affairs and Climate Policy, organised a working visit on "Legal Migration and Integration" from 26-29 November. The Agency is responsible for the implementation of government policies on sustainability, innovation, agriculture, business and international cooperation and represents the point of contact for businesses, universities and government bodies for information, consultancy, financing, networking and regulatory issues. On that occasion we recounted the virtuous experience of Su.Pr.Eme. and P.I.U.Su.Pr.Eme. through the words of the Director General of Nova Gianpietro Losapio and the Secretary General of the Presidency of the Apulia Region Roberto Venneri, representing the partnership. They spoke during the meeting at the headquarters of the Netherlands Labour Authority introduced by Astrid Tates, Senior Consultant on labour exploitation and protection of migrant workers. The Italian delegation that participated in the work included representatives of the Ministry of the Interior, Confindustria and third sector entities involved in the reception and integration of migrants



8th European Migration Forum In December we took part in the forum Migrants in Europe Today: Specific needs, skills and communication for stronger inclusion held in Brussels and attended by representatives of various civil society organisations from across Europe. There were many issues raised and addressed together with the aim of finding ways to identify and support migrants and refugees with specific needs, change the narrative on migration in the current era of polarisation and disinformation, intervene concretely to achieve more sustainable integration in the job market, and much more.
